This Is the Story of You, Me and Those Called Into God's Church

THERE CAME A TIME when the living God needed to raise up a human leader, with many others solidly behind him, in His Church for a very SPECIAL commission in these LAST DAYS of the present world.

It is undoubtedly the MOST IMPORTANT thing the Mighty GOD has done on earth in 1,900 years. It is of SUPREME IMPORTANCE to HIM — and it should be to YOU and me.

How the world got this way

Here we are in the very LAST DAYS of the evil world. NEVER BEFORE was there such a world as we have been born into. How did it get that way?

TO UNDERSTAND, I say again it is like tuning in on a 2½-hour movie when it is near the end. ~~Not having seen what went before — what led up to it — one cannot understand what he sees now.~~ So please read again, as I try BRIEFLY to hit the high spots of what led up from the beginning to the need and reason why YOU were called into God's Church and Work today. We need to have this FRESHLY in mind.

At the time of the creation of man, God had driven the first Adam out from the Garden of Eden and supernaturally barred entrance of mankind, lest he take of the tree of life (the Holy Spirit) and gain immortality in sin. Had man been allowed to acquire immortality in sin, it would have imposed on mankind an eternity of suffering, anguish, indescribable defeat.

The former Lucifer, now Satan, and his demons already had imposed such a fate on themselves.

God did not want humanity, made in His own image, potentially members of His own GOD FAMILY, to inherit any such total eternal condemnation.

So, God cut all mankind off from access to Him, or His Spirit (which would impart eternal life). EXCEPT such infinitesimal few as He would call into His service preparing for the KINGDOM OF GOD (to appear after 6,000 years).

Why?

The archangel and mighty Lucifer had been placed on the THRONE OF THE EARTH to administer the GOVERNMENT OF GOD over the earth then populated with angels. Lucifer had been PERFECT in all his ways from his creation UNTIL iniquity (lawlessness, rebellion, evil) had developed in him by his own choice. Lucifer became Satan — mighty, powerful next to God Himself, immortal, imbued with rebellion,

self-centeredness, vanity, lust and greed, jealousy, envy, resentment, bitterness, hatred, spirit of competition and strife, destruction, evil and TOTAL unhappiness.

It is God's law of His GOVERNMENT that one placed on the throne of that government must remain on it UNTIL a successor qualifies and is seated on that throne.

God's fail-safe plan

God had provided a FAIL-SAFE plan — as in a jet plane (if one system fails, another has been installed instantly to take over). God had provided that if Lucifer disqualified and the GOVERNMENT OF GOD ceased to be administered by him, God would reproduce Himself through MAN. If the first man, Adam, failed to qualify by rejecting SATAN'S WAY, and chose OBEDIENCE and the GOVERNMENT OF GOD, that Adam could have succeeded the disqualified Satan and been put on the throne of the earth administer-

ing the GOVERNMENT OF GOD over all the earth — over all mankind that would descend from him.

If this first Adam failed, then the Eternal WORD (who was with God and who was also God from eternity — John 1:1-3) would divest Himself of His immortal power and glory, come to be born HUMAN of a human mother (sired by God), would QUALIFY by rejecting and OVERCOMING Satan and his WAY, choose GOD and the GOVERNMENT OF GOD, with its way of divine LOVE.

Then being now human for the purpose of death, He would submit to death (though He never sinned, taking on Him the penalty of human sins, paying it by His shed blood for the sins of all humans who will repent of Satan's way of "GET," turn to GOD'S WAY of outflowing LOVE (the way of the GOVERNMENT OF GOD).

God had called to Him righteous Abel, Enoch, Noah. He called Abraham, who became "father of the faithful," to whom

both national, material and spiritual PROMISES were made). Four hundred thirty years later He called Abraham's descendants — then about two or three million people — as His nation the Kingdom of ISRAEL.

But they, except their prophets, were still cut off from the HOLY SPIRIT.

God promised them, and under the Old Covenant in their day, only material and national rewards. But in their carnal human minds, cut off from God's Spirit, they never accepted the GOVERNMENT OF GOD, but rebelled as had Lucifer and his angels.

Jesus Christ came, the only begotten Son of God, in human flesh. His people Judah did not accept Him. He was despised, humiliated, persecuted, rejected. Only 120 chose GOD'S WAY and followed Jesus, among them His chosen 12 apostles. He sent them into the world declaring and announcing the future KINGDOM OF GOD. It shall administer the GOVERNMENT OF

GOD, after Satan shall be deposed and put away.

God's Church raised up

Now God began to call people for HIS CHURCH. Every individual called by God had been called to a special service. Israel had been called to have GOD and HIS WAY revealed to them, but not to spiritual salvation.

But now God called HIS CHURCH, to REPENT of Satan's WAY of "GET" and accept the WAY of God's law, "GIVE" or outflowing LOVE. God gave them HIS HOLY SPIRIT, which is the LOVE OF GOD, "shed abroad in our hearts by the Holy Spirit."

Some in the Church were called to specific special duties, for God's CHURCH is a spiritual ORGANISM, well organized. In its work, God established many different operations and administrations. For this He set in His Church first APOSTLES, then evangelists (there are no prophets today), pastors, elders — some of whom were preaching ministers, some local spiritual elders, nonpreaching.

Others, the majority, the "laity," are called to TAKE THEIR PART in the WORK of the Church — not as officers in specific duties or departments but by actively and loyally standing back of the apostles and other specific administrators with their constant PRAYERS, tithes and offerings and constant loyal ENCOURAGEMENT.

But fierce and overwhelming persecution set in. A false church, deceived and influenced by Satan, rose up beginning A.D. 33. God's Church was founded A.D. 31 by Jesus Christ. By A.D. 58 much of the Church had turned to ANOTHER GOSPEL. The Gospel (GOOD NEWS) of the coming KINGDOM OF GOD, ruling with the GOVERNMENT OF GOD, was abolished and counterfeited. The true GOSPEL Jesus preached was not again preached to the world until 1953.

Commission for the end time

The time had come when God needed to call a man to lead in the final LAST DAYS' surge of 1) carrying the GREAT COMMISSION — the true Gospel of the Kingdom of God — to all the vastly multiplied 20th-century world, and 2) to raise up an enlargement of the true Church as a "BRIDE" made ready for Christ's coming — to be married to Christ.

The true Church of God, by the 20th century, had dwindled to virtual spiritual impotence, and perhaps around only 2,000 members. So far as the WORK OF GOD (carrying the Gospel of Jesus Christ about the now soon-coming Kingdom of God to the world), the Church at this stage in (See THIS IS THE STORY, page 4)

MR. ARMSTRONG DESCRIBES PLANS FOR TRIP TO CHINA

As *The Worldwide News* goes to press, details were received from Pastor General Herbert W. Armstrong about his soon-coming trip to the People's Republic of China. This information includes Mr. Armstrong's itinerary and background about travel arrangements.

The plans for my visit to Peking [Beijing], capital of the largest nation, in population, on earth, are now virtually complete. I will fly first to Tokyo, with stopover to break the long flight at Honolulu, arriving Tokyo Nov. 30, Friday. Fly to Peking Sunday, Dec. 2. There will be that night a dinner in my honor hosted by leaders in government and universities. On Monday night, Dec. 3, a banquet of about 400 men and women leaders in government and education, at which I will speak for 30 to 40 minutes.

On Tuesday night, Dec. 4, the AICF will host a dinner for the entire diplomatic corps. On Wednesday night, the 5th, there will be, sponsored by the AICF, a performance at the Nationality Palace Theater.

Thursday afternoon, the 6th, we fly back to Tokyo. Friday night, the 7th, a banquet in Tokyo, attended by Prince Mikasa, my "Japanese sons"

from the Diet, and leaders from the Chinese Embassy — and probably other ambassadors. Sabbath, rest, with possible Bible study with readers of *The Plain Truth*. Fly home Sunday.

The Chinese have a government guest house, Government State House, like the U.S. Blair House across from the White House. I will be expected to stay there.

Mr. [Stanley] Rader is now in Tokyo and has been completing arrangements.

I am personally very pleased with this schedule.

I think it is important that I am the FIRST spiritual or church leader from Christianity to be invited to visit and speak in mainland China. The officials there know very well who and what I am, all about the Worldwide Church of God, and what we believe. Surely this a door opened by God, and that is why I am going to walk through that door with His blessing and guidance.

Today Mr. Rader is seeing the U.S.S.R. ambassador in Tokyo, and it is hoped that the long overdue visit to Warsaw, Poland, may be combined with a visit to heads of the Kremlin in Moscow. Truly God is opening doors. He knows TIME IS NOW SHORT!

Iran: another blow to U.S. pride

PASADENA — "America is the great devil which gathers all the other devils around it." With these words — the epitome of global anti-Americanism — Iran's Ayatollah Ruhollah Khomeini endorsed the seizure of the U.S. embassy in Iran by militant Moslem students Nov. 3.

As we go to press the issue is still unresolved, Washington refusing to give in to the students' major demand — the extradition of the exiled shah of Iran, who is being treated for cancer in a New York hospital. Held hostage, in return for the shah, are some 60 Americans — men and women — some blindfolded with their hands tied. The demonstrators have threatened to kill them should the United States attempt a rescue operation.

President Jimmy Carter, from the onset of the crisis, publicly forswore the use of military means — admittedly difficult — to secure the safety of the American hostages, choosing instead a "diplomatic solution" to their plight. By removing such a threat, however, he greatly reduced his own negotiating leverage.

The ayatollah too knew which way the United States would act — or not act. A BBC radio broadcast from London quoted the Iranian leader as saying he did not fear military intervention by the United States because "America is too far impotent to do so. If they had been able to intervene they would have kept the shah in power."

While the U.S. government attempted to remain cool during the crisis, news sources both at home and abroad showed little restraint. London's *Daily Telegraph*, for example, called the Ayatollah Khomeini a "stupid, vindictive — some would say vicious — old man." The French newspaper *Le Monde* editorialized that "all revolutions engender some abuses, but one must admit that the

Iranian revolution is in the process of breaking all the records."

West Germany's *Frankfurter Allgemeine Zeitung* condemned the embassy seizure as a "barbarian act" but also chided the Carter administration for allowing the ayatollah to "humiliate" the United States. "He [Ayatollah Khomeini] can do this unpunished," the newspaper said, "as the Carter government neither has the will nor the strength to launch a military operation to rescue the hostages."

The West German press was by far the most outspoken in calling for ac-

Even more important," continued the *Journal*, "we have been showing the kind of weakness that tempts others to force you into these corners — in the failure to react to Soviet provocations in Cuba, in half-hearted gestures like sending unarmed planes to Saudi Arabia, in the acceptance of one-sided arms control agreements. But never was it clearer than in the current episode."

Earlier in the year the American government had already sent signals to Iran that it was in no mood to protect the U.S. embassy in Tehran — its own sovereign territory — or to

tion, not just diplomacy. Another West German newspaper, the *Süddeutsche Zeitung*, even went so far as to suggest that Iran should be invaded, the Ayatollah Khomeini overthrown and the country put under joint big power (Britain, U.S., U.S.S.R.) occupation. No mention of West Germany's NATO forces being included; it was a milestone German recommendation nevertheless.

Reveals U.S. weakness

How did the United States ever get boxed into such a degrading dilemma in the first place? Simple, answered the *Wall Street Journal* Nov. 7: "We are in this dilemma partly because we are weaker than we should be in the kinds of weapons — bases, plans, alternative oil deals — that are necessary to deal with this kind of painful crunch. Given the importance and volatility of the Middle East, the need for some kind of military presence there has been apparent for a long while — certainly since the shah fell.

guarantee the safety of its citizens.

Last February the U.S. government let the Tehran embassy be taken over without a fight. The administration avoided "over-reaction," by getting the ayatollah's forces to free it, negotiating the release of a wounded Marine and escaping with only minor injuries to the Americans involved. Apparently it thought this policy so successful it felt no need to take serious steps to reinforce the security arrangements at the embassy, let alone institute a firm policy of resistance. What were the Marine guards doing when the militants stormed the fort this time? How could they have been so easily disarmed, apparently without a fight, by an unruly mob? What happened to Marine pride?

"What this [policy of] patience brought," added the *Wall Street Journal*, "was not peace; it was more extortion, more violence, more danger of death." Now the U.S. government is pitifully reduced to letting the Palestine Liberation Organization — a guerrilla organization with whom it has no official contact — do its bidding for it! And, of course, the PLO will exact its political price afterwards.

Follows Cuban retreat

The sordid Iranian affair is the second big slap in the face for Uncle Sam in a month's time. In early October President Carter acquiesced to the Soviets over the presence in Cuba of their 3,000-man armed brigade. The President initially said he would not accept the status quo in Cuba, but ended up doing precisely that. U.S.S.R. President Leonid Brezhnev, in a much stronger position than his predecessor Nikita Khrushchev in 1962, would not budge an inch.

The Monroe Doctrine — once the cornerstone of U.S. foreign relations — now lies dead as a doornail. (It's been dormant since 1962 anyway.) U.S. President James Monroe, in his famous message to Congress in 1823, said, with regard to independent Western Hemisphere countries, "We could not view any interposition for the purpose of opposing them, or controlling in any other manner their destiny, by any European power, in any other light than as the manifestation of an unfriendly disposition towards the United States."

Many have thought Mr. Monroe's unilateral doctrine was directed toward the colonial powers of Western Europe (Spain, France and England). However, the initial thrust was against Russia. Reports Latin American historian Donald M. Dozer: "This principle was intended to thwart the pretensions of the Russian Czar Alexander I along the northwest coast of the North American continent. A specific warning to this effect had already been pointedly communicated by Secretary of State John Quincy Adams to the czar's government, and in President Monroe's message it was broadened into a general principle.

Now the Russians have been al-

lowed to get away with stationing a permanent armed force in the Western Hemisphere, 90 miles from U.S. shores. And late reports indicated the Soviets are upgrading facilities at the Cienfuegos naval base for their naval vessels, including submarines.

U.S. Secretary of State Cyrus Vance even admits that one building the Soviets are erecting is of the same type they normally use for storage and repair of nuclear missiles! In 1970 the Soviets tried to sneak into Cienfuegos — but President Richard Nixon put his foot down.

Europe concerned

American weakness, in Cuba, Iran and elsewhere, is having its effect upon America's allies, specifically West Germany.

The newspaper *Frankfurter Allgemeine*, quoted earlier, also had some pointed remarks about the United States in action during the Cuban crisis. In one editorial, its editors said: "The presence of an operational military unit of one world power before the door of the other nuclear power remains a strategic matter of explosive force. . . . SALT is no longer involved. What is involved is the credibility of American foreign policy and the effectiveness

of Washington's strategy. There is reason for uneasiness."

In another editorial, just before Washington backed down, the *Frankfurt* daily remarked: "The European allies are following with growing uneasiness the reaction of the White House to the Soviet challenge in Cuba. Arrogance, indeed scorn on the one side, Moscow's insistence upon its own interpretation of the strategic situation; on the other side, a lack of plans, confusion and helplessness on the part of the Americans."

"Before the battle really begins," the President already seems to have no arrow left in his quiver. . . . He excluded any sort of military pressure. He considers a blockade useless. He also knows that certain economic reprisals such as stopping the export of wheat to Russia cannot be used as a political measure in the year before the elections, out of consideration for the Middle Western farmers. But he has to do something, otherwise America stands before the world as a paper tiger. . . . The Europeans await deeds from their strongest ally, for their destiny and that of the Americans cannot be separated."

They're still waiting.

Israeli diplomat Ravid speaks in special forum

PASADENA — Michael Ravid, Israel's consul general in Los Angeles, Calif., spoke to more than 1,100 Church employees and Ambassador College students Oct. 23 in an employee forum in the Ambassador Auditorium. Mr. Ravid detailed some of Israel's major needs and how the Ambassador International Cultural Foundation has instituted humanitarian projects to alleviate some of the problems in his country.

Mr. Ravid traced Israel's history and described the roadblocks in establishing a nation based on traditions and writings thousands of years old. Israel would like to find archaeological proof of the Old Testament; such proof would show the validity of the Scriptures as history and legitimize Israel's claim to the territory it presently occupies.

Israel also has the massive difficulty of educating people who have extremely diverse backgrounds. To illustrate, Mr. Ravid pointed out that Israel "is the only country where the children are teaching the parents how to speak their language."

The consul general said the AICF and Ambassador College are well known in Israel. "They [AICF] don't say . . . 'do this or do that,'" he noted. "[Rather, they say] 'tell us what are your problems; in what way can we help you?'"

Mr. Ravid said that archaeological projects now underway in his homeland were important and showed how AICF and Ambassador College play an integral part in the studies. He stated that through the joint efforts of AICF and Hebrew University, "you have accomplished one of the most important things for world history." Speaking of the Jerusalem dig, Mr. Ravid complimented Ambassador students, telling them, "You students are considered to be the best workers who were at the diggings."

Because AICF is not politically motivated, many people in Israel are puzzled by the Work's efforts. Reports Mr. Ravid, "[People] try to understand why do you help us? . . . the answer which I received from Mr. [Herbert] Armstrong was that to give is much more precious than to receive."

Mr. Ravid said the AICF's Liberty Park project is having tremendous impact on the children of Jerusalem: "Education . . . starts with kindergarten, even before. The president of Israel has spoken very much about [Ambassador] College. And he has [expressed] how important it is that

Jerusalem for the first time has a really big playground for children who need school, love and to be loved."

In closing, Mr. Ravid said the Israeli officials with whom Ambassador has worked were shocked by the California attorney general's attack on the Work. He lamented, "[I]f there were more time, I could tell you what I've seen, being together with Mr. Armstrong and Mr. [Stanley] Rader on the plane in Japan, in Thailand."

Mr. Ravid spoke of the respect that many world leaders have for Mr. Armstrong, Mr. Rader and the Work, stating, "Mr. Armstrong and Mr. Rader . . . did a wonderful work by you, through you, with you."

Just one more thing

"Listen! Have you heard the one about . . . ?" Strange how those few words will perk up our ears. Or, "Say, have you heard what old 'so-and-so' is up to now?"

Seventy percent of our working hours is spent in communication, 45 percent of that time in listening. That's a good portion of the time we spend in human relationships. But how comprehensively do we listen to what others have to say?

One of our ministers once opened a sermon, "All this has been said before, but as nobody listened, it must be said once again." In the last *Worldwide News*, Mr. Armstrong mentioned wondering if some people only hear the sound of the voice, but not the words, during a sermon.

How often is this the case? How often must messages be repeated because they were not heard in the first place? In business, family, school and other personal relationships, failure to listen properly is responsible, at the least, for an enormous waste of time and energy.

It's been proven that listening requires increased energy — your heart speeds up, your blood circulates faster, your temperature goes up. So listening is a kind of activity. Those who aspire to be good listeners, therefore, must turn it from an unconscious activity to a conscious one.

It all begins with concentration. We listen to other people (family, friends, minister) through a thick screen of physical and mental distraction that can only be penetrated by deliberately applying self-control.

Physical distractions are often easily dealt with. Shutting a door or

window, moving out of hearing range of others' voices, cutting off telephone calls. The distractions generated within one's own head are more difficult to manage. The act of listening has a built-in frustration — the speaker cannot keep pace with the workings of the listener's mind.

The average rate of speech is about 125 words a minute. The average person thinks at a rate four times that fast. With all that extra time at their disposal, people on the listening side of a discussion are likely to be carried away by their own thoughts. This helps to explain why people jump to conclusions. They anticipate what is to follow instead of following what is being said at the moment. We might do well to heed the admonishment of a college professor of mine, "Now please listen slow."

Also, we are more prone to listen carefully to ideas in accord with our own point of view and to discount or mentally argue with those we find disagreeable. To listen effectively, we have to guard against this tendency toward emotional censorship of ideas that we would rather not hear.

Charles T. Copeland, a Harvard scholar, was approached by a student asking: "Why are there no courses in conversation? Is there anything I can do to learn the art of conversation?"

"Of course there is," answered Mr. Copeland, "and if you'll just listen, I'll tell you what it is."

An awkward silence followed. The student finally spoke, "Well, I'm listening."

"You see," said Mr. Copeland, with a smile, "you are learning already!"

Would You Accuse Jesus Christ?

I WRITE THIS in the form of an OPEN LETTER to a number of ex-ministers and dissident members who have gone out of God's Church in a spirit of accusation, disagreement, emotional resentment and bitterness.

I wish it might help them. I doubt if it will. But I do have high hopes that it may help the MANY still faithful, loyal and loving brethren in Christ to avoid this pitfall of Satan that has deceived some who have thought they were above being deceived by Satan.

Don't think you can outsmart Satan! Don't think you are so strong Satan could never outmaneuver, trick or deceive you! NONE of us can match wits with Satan. Our reliance must be on the one who IS stronger and more powerful than Satan — JESUS CHRIST!

What IS God's Church?

First, fasten firmly in mind just what IS God's Church. It is NOT a human or secular ORGANIZATION — it is a SPIRITUAL ORGANISM! Yet in I Corinthians 12 it is revealed as a well ORGANIZED spiritual organism, with CHRIST as living, active HEAD — actually and literally directing and guiding it!

"There are differences of administrations, but the same Lord" (verse 5). Administrations require administrators — but the Lord Jesus Christ over them, guiding, leading, controlling them.

CHRIST IS IN THE PICTURE! Yet the embittered who have gone out, accusing, have not realized they actually were accusing the living, active JESUS CHRIST! They seldom spoke of Him in the connection of their disagreement! They left Him out of the picture! They spoke of the Church, the Work, the things about which they were disgruntled or in disagreement, as if this were merely a worldly, human organization, which a man named Herbert W. Armstrong had somehow maneuvered to make himself the HEAD (which he certainly NEVER did) and with whom they DISAGREED!

One, my own son, has said, "I never did agree with my father."

Several, probably not realizing it, have been accusing Jesus Christ, the living HEAD of God's Church. Be sure YOU don't!

He spoke as if it were Christ's human apostle who was wrong. He did not seem to see CHRIST as LIVING, ACTIVE HEAD, merely using His chosen apostle as His instrument — almost comparable to a puppet — with CHRIST as the living, responsible, active HEAD! If in viewing a puppet show you disagree with something the puppet is caused to do, you are actually disagreeing with the one ABOVE, who is manipulating and guiding what the puppet on the strings is doing.

But the dissidents have made their accusations and disagreements against the "puppet" — for they would fear to accuse Jesus Christ directly! Yet, indirectly, that is precisely what they have done, whether realized or not!

Who is head of the Church?

A parallel case is found in I Samuel 8, when GOD — the YHWH who later became Jesus Christ — was ruling Israel through His instrument Samuel. The people became dissatisfied, disgruntled. They decided to overthrow Samuel. They, like our dissidents today, could not see GOD in the picture. They saw only the human Samuel.

They wanted to do away with Samuel and have a king like the other worldly nations.

But what did GOD (in the Person who is JESUS CHRIST today) say?

"And the Lord [YHWH] said unto Samuel . . . they have not rejected thee, but they have rejected me [the future CHRIST], that I should not reign over them" (I Samuel 8:7).

They did not realize it was the future CHRIST who had brought them out of hard slavery and bondage in Egypt, set them up as HIS NATION, brought them into the promised land and was their REAL ruler!

Nor do the rebellious dissidents (and perhaps even some loyal members) realize today that it is CHRIST who raised up HIS ONE AND ONLY CHURCH OF OUR TIME (even though He used me as His servant — his "puppet" so to

peak).

The LIVING Jesus Christ put HIS GOVERNMENT into God's Church. He prepared me for years before He called me to be His servant — His chosen apostle — His puppet as it were.

But there is one DIFFERENCE in the puppet analogy: Christ chooses His prophets and apostles as human men with MINDS — whereas a puppet, of course, has no mind. A servant GOD uses, therefore, being human, can make a mistake. But if he does, it is CHRIST'S responsibility to correct him — not the Church members or ministers Christ has placed under him.

To illustrate, take King David — a man after God's own heart. GOD USED David. But David made some mistakes. One terrible mistake — a terrible sin — was when David had Uriah killed — a MURDER — so he could cover up his sin of adultery and have Bathsheba for his wife.

BUT IT WAS NOT THE PLACE OF THE PEOPLE UNDER DAVID TO CORRECT HIM! That was GOD'S responsibility. AND GOD DID NOT NEGLECT IT! He sent His prophet Nathan to make David realize his sin. David repented — REALLY repented. Read his prayer of repentance in the 51st Psalm!

It is GOD'S responsibility to correct His chosen apostle — not YOURS — not the minister under him, though I would listen gratefully with open mind if one prayerfully came to me in sincerity, about any disagreement. But CORRECTION and any ACCUSATION against God's apostle is NOT the responsibility of the ministers or the members — that is CHRIST'S responsibility — AND I KNOW, IF SOME DON'T, THAT HE IS NOT "ASLEEP ON THE JOB."

DO NOT take it upon yourself to take CHRIST'S responsibility away from Him! When you do, IT IS CHRIST you accuse, not His servant who is merely His instrument, trying with all his might to faithfully obey Him!

The POINT of this article is: Some have, and others may, not realizing it, ACCUSE CHRIST, sup-

posing they are only venting their emotional accusation or disagreement or resentment on a FELLOW HUMAN BEING.

When the pope of Rome visited the United States in early October, he answered some Roman Catholic dissidents, who disagreed with traditional Catholic doctrines and teachings, by calling them "a-la-carte Catholics" — those who chose which teachings and doctrines they agreed with — and said they were not really Catholics!

There is one difference in the analogy — in Roman Catholicism, the pope is the living HEAD of the church, while in the Church of God, CHRIST is the living Head. In the Catholic Church, they claim that the CHURCH, guided by the pope, is the AUTHORITY — while in GOD'S Church, the BIBLE is the authority!

We sent Gene Hogberg during the pope's U.S. visit, traveling to the various cities where the pope appeared. In his very fine article in the December Plain Truth, a masterpiece of journalism reporting his coverage of the papal visit, he notes that the pope said nothing or almost nothing about the living Christ. The pope's official title is "Vicar of Christ," which means "IN PLACE OF CHRIST."

How Christ put me in His Church

Dissidents are always misrepresenting experiences of the early days — events they know nothing about — of how Christ brought me into God's Church.

When the TRUTH is known, what a contrast from the way dissidents have acted in our time.

An article in The Worldwide News has covered much of how God brought me into His Church. Let me here cover a few other significant experiences of those days.

God had brought me through a business experience preparing me for certain activities He would require of me after He called and conquered and converted me. During that intensive six months'

preliminary almost night-and-day study, God revealed to me certain very basic, fundamental TRUTHS needful for the commission to which He was calling me. One, most basic, was the GOVERNMENT OF GOD: based on the LAW OF GOD, and the fact that the real TEST COMMANDMENT of God's law is the Sabbath. Another was the truth of U.S. and British true identity as the birthright tribes of the "lost" 10 tribes, the house of Israel. Another was the annual Holy Days.

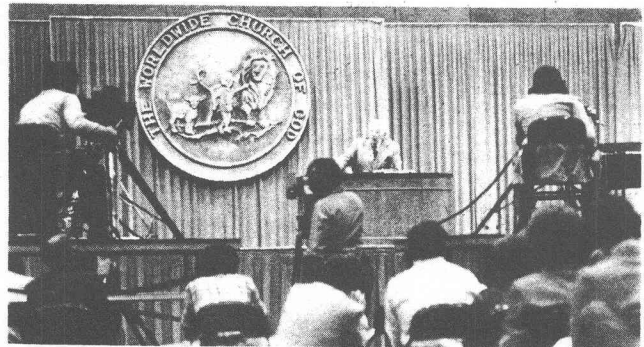
I was in close touch with Seventh-day Adventist literature (but not with the church) and with the Church of God, Seventh Day, and with their members in Oregon.

One of the first things I learned was that both Catholicism and Protestantism teach the precise OPPOSITE of the plain teaching of the Bible. This brought great perplexity and consternation. I had, since age 18, lost all active interest in church and religion — yet I supposed at least the Protestant churches were true churches of God. Now I asked, in bewildered hopelessness, "WHERE, then, is the one TRUE Church Christ founded?" I read in Matthew 16:18 that the true Church would not die out.

I knew it had to believe in the LAW of God, and that the test commandment was the Sabbath. That narrowed the possible TRUE Church down to three — the Seventh-day Adventists, the Seventh-day Baptists and the Church of God, Seventh Day. Then I learned that the TRUE Church always would be kept in the NAME of the FATHER, GOD! That left only the one.

But I could not readily accept them as God's one true Church. They seemed too small — less than 2,000 members, nearly all in the United States, if not all. They were weak and impotent spiritually. They did not know or preach the TRUE GOSPEL, but a "third angel's message." They had no understanding of the KINGDOM of GOD or what would take place in the Millennium — they knew only there would be a thousand-year reign with Christ ON EARTH, but no details about it.

Yet I knew of no other that could be the true Church. With this lack of real PROOF, my wife and I decided NOT to join them (See WOULD YOU ACCUSE, page 4)

time had "a name that thou livest, and art {spiritually and in the work} dead" (Revelation 3:1).

The time had come for God's Church to spring to new life, spiritual vitality and energy.

The time had come when the Church must carry that shocking, dynamic Gospel in power to a dying world that had not heard it for almost 1,900 years — a message that would sound incredible, false and prejudicially crazy to a modern 20th-century world, far advanced in material, scientific and technological advances — a world spiritually DRUNK (Revelation 17:2) and DRUGGED mentally on the FALSE teachings of the great false church that started under Satan two years after the Church of GOD was founded in A.D. 31.

Incredibly IMPOSSIBLE

How could the true Church, starting from the condition in the first quarter of the 20th century, suddenly spring to life and growth, and accomplish such an IMPOSSIBLE mission in such a world, wholly in Satan's deceptive grasp?

The answer may be found in Zechariah 4:6, prophetically speaking to Zerubbabel, who built the second temple at Jerusalem, and a forerunning type of the one God would in these last days raise up to build up the temple to which Christ will come at His Second Coming. "This is the word of the LORD unto Zerubbabel, saying, Not by might, nor by power, but by MY SPIRIT, saith the LORD of hosts."

The job of building the second temple was probably only by physical strength. The Holy Spirit had not been given, except to the prophets, prior to Christ's glorification after His resurrection (John 7:37-39).

So it referred to the one God would raise up in this 20th century, of whom Zerubbabel was a type and forerunner. The WORK today can be done ONLY by the Holy Spirit of GOD in US who now compose His Church, for we of ourselves have but LITTLE strength (Revelation 3:8).

So HOW did God go about it, IN OUR DAY? I never dreamed I would ever be called to such a mission for God. At age 18, in 1910, I had dropped out of church attendance and Sunday school. I virtually lost all interest in "religion," though in no way had turned against it.

Yet even then, in a way I did not realize, Jesus Christ was guiding my life, even in this materialistic world. He was guiding my life then so that later He might guide YOURS who are Spirit-led members of His Church today.

He led me to choose a profession — at age 18 — that GOD knew would give me training and experience to be needed later, when He did knock me down, so to speak, and call me to His service — at age 34. By that time I was an experienced magazine writer — experienced in a writing style that MADE THE MEANING PLAIN to the GRASS-ROOTS PUBLIC — if not the scholarly. I was experienced in both newspaper and magazine production. I was experienced in travel, in contacts with the great and near-great in the American business world. I was experienced in dealing with advertising agencies. I had some public-speaking experience. ALL THIS WAS TO BE BASICALLY NEEDED IN GOD'S WORK.

WHY is this Work of God bigger than Billy Graham and Oral Roberts combined, as the CBS news program, *60 Minutes*, told the nation? Neither of them ever had that preliminary experience and know-how. They raised up

no church — published no magazine, in comparison, to the PT. In God's Church, that pre-experience made all the difference! I had been prepared in advance to speak on radio, to publish *The Plain Truth* and other magazines, and write so many vital booklets and books. And without radio and the printing press this Work never could have grown as God caused it to grow!

BUT NOW GOD HAD TO ENDOW ME WITH MUCH MORE! Principally, the knowledge and UNDERSTANDING of GOD'S WORD! In the fall of 1926 God caused me to be put through an angered, yet open-minded and superintensive study and research of evolution and of GOD'S WORD.

I know of NO MAN who has ever been put through such an experience, which swept my mind CLEAR and CLEAN of all contrary religious, biblical or spiritual ideas or beliefs. Into a mind CLEARED FOR IT, Jesus Christ poured in GOD'S TRUTH! He showed me that this world's "Christianity" teaches the precise OPPOSITE to Bible TRUTH!

Another important point — God chose a man who from a child had craved understanding. So in this ordeal He put me through HE GAVE ME UNDERSTANDING of His TRUTH!

He had to bring me to total surrender to Him, to TURN FROM Satan's way of "GET" — to a real REPENTANCE until I was CONQUERED BY HIM, and then to a living FAITH in Christ, which was to become the foundation on which this Church and Work was built.

How the Work developed

Now in this world, most organizations or corporations that are big started with MONEY — adequate financial capital. God

deliberately and for good reason TOOK ALL OF THAT, WHICH I HAD, AWAY from me. I had been very successful in Chicago, as a publishers' representative, making what in today's dollar value would be an income of \$175,000 to \$200,000 per year.

That was an exceptionally BIG income for a young man still in his 20s! But God knew it would be good for me and His Work to be making it, and then, for no reason of mine, HAVE IT TAKEN FROM ME. The flash depression of 1920 — when I was 28 — swept away, or into receivership, all my biggest clients.

Later I was developing a very successful advertising business in Portland, Ore., but, unknown to me, an action taken in Indianapolis, Ind., took away ALL my clients, at a time when my advertising was doubling and tripling their volume of business!

God did not start His Work of this Church with MONEY or financial capital. It was started in ABSOLUTE POVERTY and HUNGER! It was started on SHEER FAITH — and some "guts" amid much opposition and persecution!

But by 1933 Christ had me where He wanted me — in material and financial POVERTY — but RICH in UNDERSTANDING and KNOWLEDGE of His TRUTH, and in FAITH. It was not by physical or material strength, but by GOD'S HOLY SPIRIT.

Learning God's TRUTH did not come easy. The living Christ had to teach me, through His written Word, a doctrine at a time, and then unscramble them, and, like a jigsaw puzzle, let Him lead me in putting them all together in SEQUENCE. Thus He gave UNDERSTANDING of GOD'S PURPOSE, GOD'S MASTER PLAN, the prehistory of God's dealing with the angels on earth, God's dealing with MAN from Adam to

NOW! UNDERSTANDING of the CAUSES of today's world evils, of how and WHY God allowed the churches of traditional "Christianity" to be deceived by Satan the devil.

Jesus Christ used me to receive all the wonderful TRUTH, at the cost of GREAT EFFORT, suffering the persecutions of Satan as probably no other man in our time. He did this so that through me He could GIVE YOU all this tremendous gold mine of TRUTH already dug out for you — handed to you, so to speak, on a platter.

You did not have to go through the severe traumas He put me through to receive this TRUTH beyond normal understanding.

He used me to found Ambassador College, providing part-time employment so many could work their way through — with the PRECIOUS TRUTH handed to them freely. They did not have to go through what I did to receive it. It came dearly to me — cheaply to many students.

Yet all the while I was only an instrument — a SERVANT of the living CHRIST!

Praise His name above all names, HE did it — I didn't. Yet I have paid a price in HARD WORK, SACRIFICE ABOVE ALL, PERSECUTION, HAVING LOVED ONES I HAVE SERVED TURN ON ME AND DESIRE TO DESTROY ME, AND THE WORK OF THE LIVING JESUS CHRIST! Some have threatened my life.

But you in the Church as a whole have remained LOYAL in Christian and deep LOVE! I KNOW, dear brethren — my dear children in Christ — how you love me. And I LOVE YOU with a depth of love that perhaps only God can comprehend!

May HE ABUNDANTLY BLESS YOU and bring you, with me, into His Kingdom, FOR EVER AND EVER!

until more sure — but to begin meeting with them, attending their services, fellowshiping with them. They were a humble, plain, yet sincere people. They had one major doctrine ALL accepted — the weekly Sabbath.

Otherwise, they were divided in doctrines — a sort of a-la-carte religion. Elder Stith believed there was no devil. Elder Dugger and many ministers believed there was. Some believed Christ would come before the Millennium, others were postmillennialists.

Proper channel for questions

Now what did I do? What example did I set, so radically DIFFERENT from some who have gone out from us today?

Remember I was not even a member. I was not even a minister, from my conversion — early 1927, until 1931 — and then ordained by the Oregon Confer-

ence, separately incorporated. I did begin preaching a bit about 1930. I continued intensive Bible study.

I realized I did not agree with them on certain points, especially some God had been revealing to me. They knew nothing of our identity as the birthright tribes of Israel. I DID NOT PREACH OR TEACH THIS or any other doctrine contrary to their general teachings! Instead, I did what a very few disagreeing ministers today should have done — I refrained from preaching it to their members, but I did take it privately to their headquarters! In this case, I wrote a manuscript that later, with revisions, became our booklet *U.S. in Prophecy*. I sent this to their headquarters at Stanberry, Mo. I could not afford to travel there in person.

After much delay, the answer came back from their executive leader, A.N. Dugger, saying it was the TRUTH — God had a pur-

pose in revealing it to me — but the church could not accept or preach it. He REJECTED TRUTH, which he admitted was truth! His letter was photographically reproduced in the first edition of the autobiography. I did NOT teach it to their members!

They did not agree or have the truth about the annual Holy Days. I took this up privately with their leaders. They "laughed me to scorn," rejecting the TRUTH. I carefully refrained from proclaiming it to their members. But when the parent Church of the present Worldwide Church of God was raised up in 1933, I did teach it to them, our own brethren, and they received it!

There was another very small teaching in which they were in error — re: Matthew 28:1. I did not go to their members with it, but I wrote an 18-page analysis PROVING their error, sent it to Stanberry headquarters. They

admitted in writing I had proved them in error, but said they could not correct it, because many older members and ministers would not accept it, and for the sake of unity they would have to continue teaching the error.

A few ministers — a very few — have gone out in the past year, saying they disagree on some doctrines — but they never brought their disagreement to headquarters to "Come . . . let us reason together" (Isaiah 1:18). "They went out from us, but they were not of us; for if they had been of us, they would no doubt have continued with us" (1 John 2:19).

Brethren, God has not given His people an a-la-carte church where each picks whatever doctrines HE or SHE prefers and rejects the others!

Speak the same thing

God says, through Paul: "Now I beseech you, brethren,

by the name of our Lord Jesus Christ, that ye all speak the same thing, and that there be no divisions among you" (1 Corinthians 1:10), for speaking or preaching DIFFERENT doctrines causes DIVISIONS, and God commands, "Now I beseech you, brethren, mark them which cause divisions and offences CONTRARY TO THE DOCTRINE which ye have learned" (when you came into the Church) "and avoid them" (Romans 16:17).

God, from the founding of His Church, has put HIS DOCTRINES and TEACHINGS into His Church THROUGH HIS APOSTLES! I have PROVED, brethren, through the years, that if an incorrect teaching, belief or doctrine has been put into the Church through me, that my mind is OPEN — that the living CHRIST will cause me to see it — and in that way He will correct it through His servant.

CHRIST GUIDES AND RULES HIS CHURCH!

Following are individual reports as of press time from 70 of the 76 Feast sites around the world.

These reports were written from information supplied to *The Worldwide News* by Festival coordinators whose names appear at the end of each report (except in a small number of cases when a non-English-speaking coordinator had someone else file an account).

UNITED STATES

ANCHORAGE, Alaska — Three hundred eighty-five brethren of the Worldwide Church of God enjoyed beautiful weather and mild temperatures during the 1979 Feast of Tabernacles in Alaska. A high point of the Festival came when Gerald Waterhouse closed the season on the Last Great Day, as more than 80 percent of the brethren had never seen Mr. Waterhouse. Brethren also appreciated being able to view Herbert W. Armstrong's opening messages on film. Other principal speakers contributing to an overall theme of preparing the Church to become Christ's Bride included Earl Roemer, Robert Berendt and Harold and Ken Treybig.

The annual Festival barbecue, a formal dinner-dance, a YOU dance, a movie night for children and a ministerial open house made up a few of the activities enjoyed by the brethren meeting at the Captain Cook Hotel in Anchorage.

For many, the 1979 Feast was a spiritual high, characterized by a super attitude. All are now eagerly anticipating the 1980 Feast. *Earl L. Roemer.*

BILOXI, Miss. — A spirit of fellowship and cooperation pervaded the new Biloxi Feast site, as nearly 7,000 brethren enjoyed beautiful warm weather on the Gulf of Mexico. The inspiring climax of the Feast came by microwave as Pastor General Herbert W. Armstrong spoke to the brethren gathered in the Mississippi Coast Coliseum and Convention Center.

The Festival theme was about God's government, with main speakers Herman Hoeh speaking on prophecy and proper child rearing, Don Ward on the Church as a spiritual priesthood, Roderick Meredith on making your commitment strong in the end time, Bill Bradford surveying God's government as it appears in the Bible and John Robinson presenting an inspiring Bible study.

YOU sponsored several events, including a YOU dance, a YOU booth at a park, the YOU Variety Show and the annual YOU day at services. Senior brethren were honored at a senior citizens' afternoon. Other activities were a dinner-dance for adults at the banquet hall and a noteworthy Feast fun show. *Richard Thompson.*

FRESNO, Calif. — A real spirit of love and concern was topped off by Pastor General Herbert W. Armstrong's powerful sermon by microwave from Tucson, Ariz., Oct. 13 for 3,936 brethren of God's Church in the Fresno Arena. A family talent show, YOU and singles dances, all-Church dinner-dance, amusement parks, senior citizens' dinner and arts-and-crafts show were but a few of the activities enjoyed by the brethren.

'79 FEAST OF TABERNACLES

Service was a major key as people pitched in to help one another in a spirit of real Christian love. In summary, it was a literal spiritual Feast of togetherness. *Dale L. Schurter.*

LAHAINA, Hawaii — Twelve hundred brethren of God's Church enjoyed an inspiring Feast of Tabernacles here amidst beautiful tropical weather.

Members were exhorted to begin preparations for becoming the Bride of Christ. Key speakers were Dennis Luker, Wilbur Berg and Leroy Neff. These ministers and their wives were presented with special maile leis as a customary token of love and appreciation.

Overall, the underlying spirit of cooperation and unity made the Feast in Pasadena a memorable occasion for everyone. *Joseph Tkach Sr.*

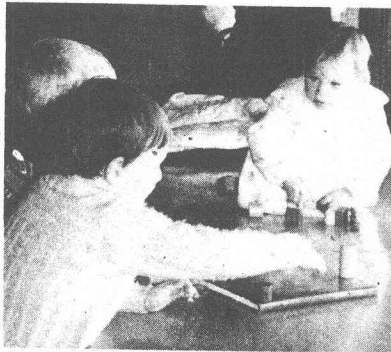

LEWISTON, N.Y. —

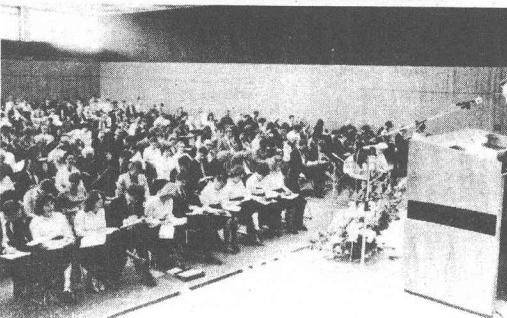
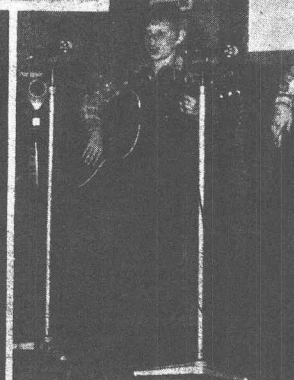

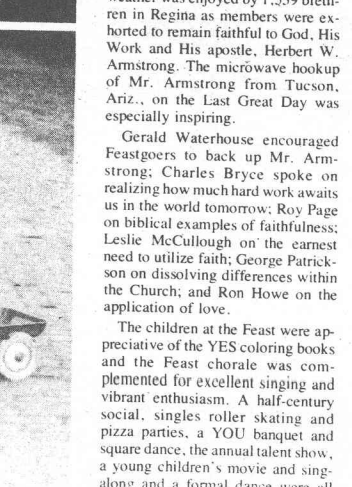
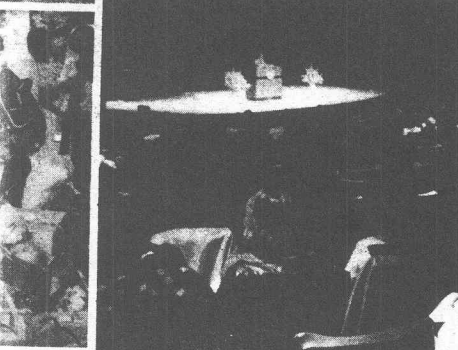

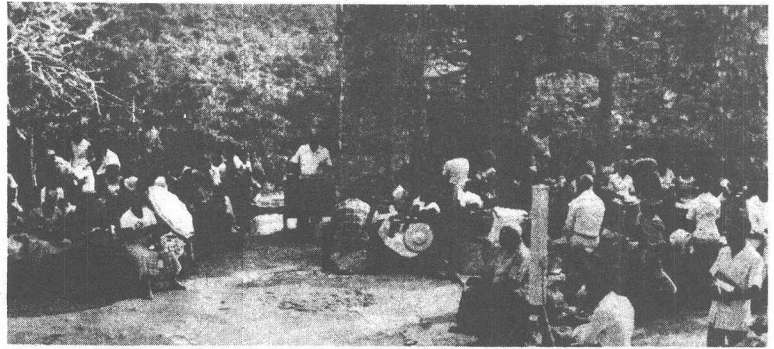

Church leaders were interviewed by reporters for coverage in Port Macquarie. *Peter Whiting.*

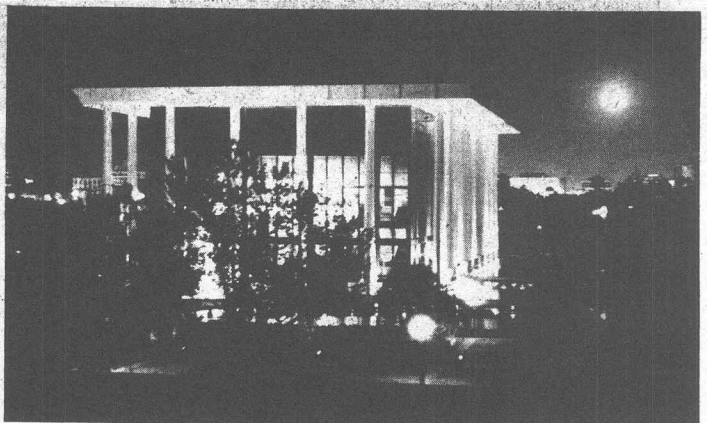

Mr. Helge's comments on Church's legal battle

Following is the substance of a message given Oct. 13 by Church attorney Ralph Helge at the Seattle, Wash., Feast site, concerning the Church's legal battle.

I want to state that the charges and the complaints that were filed against the Church of God were drafted by a private attorney for dissidents of this Church, to which the attorney general of California lent his name, and the power of the state, and that was the full extent of the attorney general's investigation, that [which] the attorney for the dissidents had written.

Those charges — and I hope to put it in an article, the details of it — are absolute lies. Absolute lies! The case was engendered — so you will know and understand without a doubt — and exists because of political and judicial corruption. The quintessence and the purity of corruption. Before God, I lie not.

As I said in Pasadena, and I say again, when this case is done, you are going to find that there are criminals involved in the case. You are also going to find that the criminals are not the Church members or the Church leaders.

This case, everything we've done in it, virtually has been denied by the court because of what I just told you. Everything that the attorney general and his men have asked for has been granted, because of what I just told you.

It's come down to a point now where the only physical hope, and I repeat, physical hope, lies in the State Supreme Court and the federal system. Now because of this, when it comes down to the law in California, that because of the nature of the case, somebody shortly — one of your Church leaders — is going to have to be held in contempt of court to have the matter heard.

All these writs you've been filing — you've been hearing about — are only discretionary. They don't have to hear them. Once someone is held in

contempt of court in California then they must hear the case. So I say, it's coming to a point now in which one of your leaders is going to be held in contempt of court. That can mean one of two things, either a fine or a jail sentence.

Now if there is enough political corruption, the court will be forced maybe to do both. Otherwise I don't think they would hold somebody in contempt of court and put them in jail, but if there is enough political corruption, and they're going to press them to do it, some of your Church leaders, I tell you, are going to go to jail.

Now understand this when it happens. That when it does happen it's not going to mean that the charges and the complaints of stealing and pilfering millions — which I say is a lie — are true. It's simply going to mean that the court order to turn over every Church document and control the Church properties is not going to be obeyed. It's not on the basis of some singular legal principle that your Church leader will be standing upon.

As Mr. Armstrong said in his proclamation, it's an issue of whether or not the state is going to run this Church and preach this Gospel. For that issue, as I say, some of your Church leaders may be going to jail.

Now some in Pasadena have already committed themselves, resolved themselves, to this fate. They have it in mind [that] it's going to happen, and they are going to be taken away. They are set in their minds that they are going to remain firm.

It's a funny thing. I pick up today's paper out here, and what does it say about a local minister here in Seattle? "Pastor Risks Jail, Contempt of Court," just to keep his school open.

Okay, so now what is the point? The point is that we are concerned, right? About ourselves? No, about you! You say, Helge, I must have missed the point! You said the leaders are going to go to jail maybe, and you're concerned about us. That's right! Because as Paul mentioned, we don't want you to fall prey to Satan. Now I'll tell you why the concern

is. I have seen over past years some people mistake superstition for faith. I remember one man telling me, "Well, I'm going to go into this business deal." I said, "You know, that doesn't sound like too good a deal." He said, "Well, I'll tell you, God wouldn't let me do it if it wasn't right or good, because I prayed to Him about it."

Now I tell you that's a false premise. He said, "Well, I prayed to God, 'Now if I'm not supposed to go into this deal, don't you let me get that money out of the bank.'" All he had to do was go down and sign a piece of paper to draw it out of his account.

So you see, it was superstition, not faith. They were substituting miracles for what? For a knowledge of the scripture and applying it with wisdom.

So now, what would you think if you hear that Mr. Herbert Armstrong, or Mr. Stanley Rader, or myself or somebody else, some of the other ministers, were taken to jail? Now what would you think if you saw on TV or in the newspaper a picture of Mr. Armstrong, and he was chained to a marshal, walking to jail? Then behind him chained, manacled, was Mr. Rader or another leader?

Now what would you think if you actually saw on TV where they were locked in the jail? Now what would you think if there were crowds all around the courtroom, jeering and taunting them?

Now tell me, what would you think, if in Pasadena the entire city was out there, and they were screaming and shouting: "Down with the Church of God! Down with their leaders! Down with the college!" What would you think? Would you think, that can't possibly be the Church of God if all those people are against them?

What would you think if the plane — if they were taking off to go to China — maybe crashed on the runway causing some slight injury to them? What would you think if they were dragged out of the city, dragged out and beaten? . . . What if you saw

somebody come up and just punch Mr. Armstrong in the side of the mouth? Would you say that [he] couldn't be God's apostle? Would you think that?

What if every place you went in the Feast, every place you went, the Church was spoken evil of? Would you say, you know, that couldn't be God's Church? What would you think if they were beheaded? What would you think? Would you think this is a sure sign from God this is not God's Church? You know, this couldn't happen to God's Church?

Now I tell you, everything that I said there — for those that have been in the Church for awhile, you realize every example I gave — everything that I talked about there, is what did happen to God's people, to God's apostles, to God's ministers in the Scriptures. Can you believe that? That is what happened to them, that is what occurred. So are you going to think that if somebody is held in contempt and they go to jail it's not God's Church?

No, you see, these are the things that have happened. So when they are held in contempt, don't think it's a sign that it's not God's Church, don't be superstitious, but rather look to the Scriptures.

Here are a few. How about Acts 14:22, that "Through much tribulation you shall enter into the Kingdom of God"? What about John 16:33, "In the world you shall have tribulation"? What about II Timothy 3:12, "All who live godly in Christ Jesus shall suffer persecution"?

So when it happens, brother, maintain your faith. Believe me, it's not a sign that you should pull away from the Church. It's not a sign that you should go out and join the church of dissidents, of Satan's rebels. No, it's not a sign for that. It's a sign that the Scriptures are being fulfilled. It's a sign for you to strengthen your faith and maybe know that the time is closer now to the end than when you first believed.

You know, you're here, you've been taught, we've all been taught —

myself for over 25 years — that we're to look to headquarters. That is fine, but I tell you, if they're held in contempt of court, or if I go to jail because I will not concede to Satan's demands, but I am determined to remain faithful, as other men in Pasadena have, I tell you, it's going to be a reverse situation.

You're not going to be looking to headquarters; headquarters is going to be looking out to you! I'm going to be looking out to you. I pray that you will go back and you will read Acts 12, that if people are held in contempt of court you will get on your knees and you will pray. As that Church prayed Peter out of jail, you will pray your leaders out of jail. Because I tell you there is no faith in the system.

You see, God said He put the basest of men in the governmental positions. He writes in the Scriptures — as Mr. Rader mentioned yesterday and Mr. Armstrong has taught long ago — He talked about the unjust judges. You've got to understand one thing. That when you come down to political corruption, a political person you see, he is like a political animal. He has no life hereafter, this is his only life, this political life that he has, and the instinct to survive is strong. It is strong, it's almost stronger than the human grasp for human life. The question is how far will they go to maintain that political status?

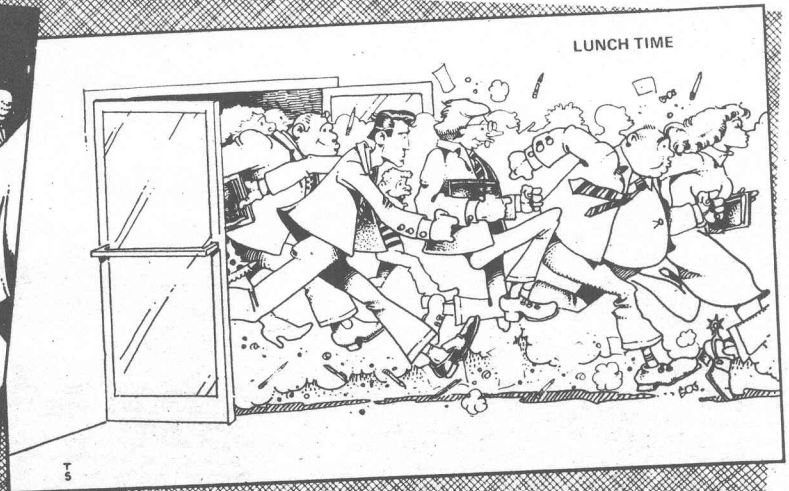
Read your history, there is no end. It can be rape, assassination, murder, sedition, rebellion, anything to hold onto that political status.

So the mere fact that they are going to put some of your leaders in jail, believe me, that is nothing. The highest concern is not that they are going to just put somebody in jail, but frankly, what else they may do before this case is over, and certainly what else they are going to do before this era is over.

So I just want to bring that very brief message to you to tell you and plead with you, search the Scriptures, don't be superstitious, and pray because headquarters is looking to you and your power of prayer and contact with God.



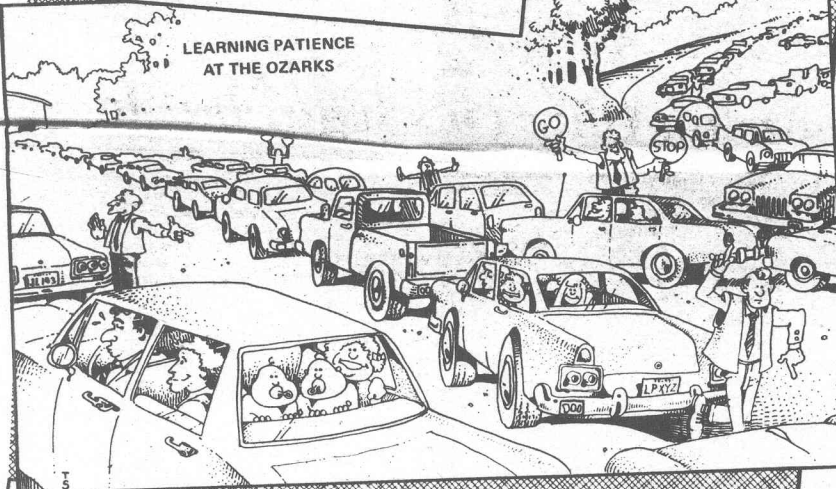

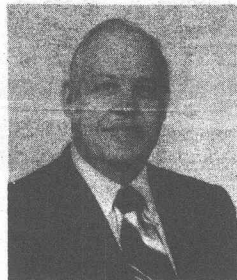
Mr. and Mrs. Neff heard Mr. Armstrong on the radio early in 1951 and met him at a Portland, Ore., Sabbath service later that year.

Mr. Neff has pastored churches in Long Beach, Calif.; Big Sandy, Tex.; Shreveport, La.; and Houston, Tex. He was an associate professor of theology at Ambassador's Big Sandy campus, and also served

as controller and secretary-treasurer of the college there.

Mr. Neff was senior pastor of the Texas coast area in January when the State of California attempted to

I heard a rumor that the Feast Office is being shut down. Is it true?

This will eliminate the duplication of effort we experienced when the office moved from Big Sandy, Tex., to Pasadena.

Absolutely none. Mr. Armstrong, in a meeting with Deputy Chancellor **Raymond McNair** and others, did slip once when he introduced **Honse** (a small German schnauzer who wears a badge and is referred to as the "Deputy Sheriff") as the deputy chancellor. Mr. Armstrong quickly corrected himself — as everyone ribbed Mr. McNair. This is the closest we know of anyone becoming the new deputy chancellor.

STATEMENT OF SUPPORT — Church treasurer **Stanley R. Rader** at an employee forum in the Ambassador Auditorium Nov. 6 discussed the Church's court litigation. Mr. Rader, an evangelist and **Herbert W. To the Honorable Chief Justice and Associate Justices of the California Supreme Court:

On behalf of our client the Roman Catholic Archbishop of Los Angeles, a corporation sole, organized and operating under the laws of the State of California, we are addressing the Court to urge that petitions for hearing in the above-entitled proceedings be granted.

Statement of Interest

The Roman Catholic Archbishop of Los Angeles, a corporation sole, is the officially designated entity of the Roman Catholic Church in the area encompassed by the Archdioceses of Los Angeles, consisting of the counties of Los Angeles, Ventura and Santa Barbara. As such, together with many other churches and religious organizations, it is vitally concerned with the subject litigation and particularly with the position assumed by the Attorney General of the State of California in justification of the position and actions taken by him in this litigation. We submit that a more complete departure from the long established constitutional principles and tradition of religious freedom can scarcely be imagined.

Statement of Support

As clearly disclosed by the pleadings and record, the Attorney General specifically asserts that all Churches in California hold their assets in trust for the benefit of the general public, that no Church has any proprietary interest in any of its property or assets and no private rights with respect thereto, that Church officials are mere trustees serving at the sufferance of the Courts and that all Churches are, in fact, under the control and as such, ~~are~~ ^{are} ~~subject to~~ ^{subject to} supervision and control by the State. In brief, the Attorney General claims that, despite constitutional restrictions, the religious nature of a Church does not limit or restrict the power of control and supervision which he claims to possess over secular charitable organizations.

It must not be overlooked that this action is directed against the Church itself, not merely against other individual or secular defendants. The relief demanded is substantially directed against the Church; a complete accounting by the Church of its affairs for the past 5 years, appointment of a receivership to take complete control of all property, books and records of the Church, and the replacement of Church officials as determined by the Court. It is important to note that the complaint herein does not purport to allege wrongful acts by the Church, per se, but rather (almost entirely upon information and belief) alleges wrongful acts by various individual defendants, with alleged damage or loss suffered herefrom by the Church or its members.

Certainly it is not our position that wrongful or fraudulent actions of the type charged against the individual defendants should be disregarded. However, other adequate remedies are available against the individual defendants if appropriate. Basically this is an intra-Church controversy and involvement of the Attorney General can only be justified by the above described assertion of unlimited powers of supervision and control of charitable organizations without limitation because of the involvement of religion.

In this matter, the Attorney General has elected the type of action to be filed, the scope of the relief to be demanded, and the defendants to be charged; the basis of justification is clearly and specifically stated. In so doing, the Attorney General has raised constitutional issues of serious magnitude. It seems almost point-

less to ponder the extent of permissibility of entanglement of Church and State, despite the care with which such matters have been treated by innumerable courts, when faced with the virtually unlimited assertions of governmental right of supervision and control herein claimed by the Attorney General.

This basic issue is the focal point of our concern, and surely that of all persons and organizations interested in religious freedom. The basic issue is squarely before the Court. If, as we sincerely contend, the actions of the Attorney General involve an unconstitutional abuse of the power of government, the discovery orders here involved, together with the entire action, must fail.

This basic issue can and should be determined at this time. We respectfully submit that the Attorney General has now placed this issue in a position where failure to address this issue can be interpreted as at least indirect support of the position asserted by the State. Indeed this approach has already surfaced. (cf. Attorney General Response to the Petition for Hearing and Application for Stay, proceeding 57303, page 2). Until determined, this issue can be expected to reappear again and again, both in the subject action and in inevitable litigation involving other Churches; as clearly indicated by the diversity of the organizations formally requesting that these petitions be heard and the intensity of their views as expressed.

We respectfully urge that the Court grant these petitions in order that this crucial issue, and others presented, may be given urgently needed consideration, in which event we respectfully request permission to file a brief as *Amicus Curiae* in support of the petitions.

HOTLINE

The following information was provided by official Church sources to answer many of the questions generated by the crisis in the Church.

We have received several letters with questions addressed to "Hotline." The questions were valid in most cases but could not be answered because they were anonymous. To request your name be held in confidence is fine, but to omit it or sign "concerned Church member," "one who cares," etc., is not. These questions, according to our policy, will not be answered.

I understand that the Church of God, International, held a "feast" in Squaw Valley, Calif. Why couldn't we get Squaw Valley?

We did check on this site and found it was unsuitable and unsafe for our use. The state has condemned Squaw Valley for any group of more than 2,000 people. To bring it up to Occupational Safety & Health Administra-

tion standards would take \$4.5 million. The Olympic Committee has once again decided to stay. If this decision stands, they plan to invest \$65 million to revamp the entire area over a period of four to five years. We are already booked, depending on when the area becomes available.

I question your answer to the person who asked about "seeking vengeance" in the Sept. 24 "WN" "Hotline."

There seemed to be considerable concern over the discussion of the "eye for an eye and a tooth for a tooth" principle in a recent hotline. A more lengthy explanation by letter was given to the person who originally asked the question. The quote was merely showing that, out of context, one scripture can seemingly contradict another. A lot of people apparently spend their time wrestling scriptures in this fruitless manner. You should try to understand what is happening in view of the overall picture. Mr. Armstrong, as always, knows what is happening, and there is no wrong attitude in the many legal steps we must take.
